IF NOT, INTEREST WILL BE ADDED AT THE RATE OF 1% PER MONTH OR FRACTION THEREOF FOR THE FIRST THREE MONTHS AND 1 1/2% PER MONTH THEREAFTER TILL EACH INSTALLMENT IS PAID IN FULL. AN 8% PENALTY ON THE TOTAL TAX DUE WILL BE ADDED IF NOT PAID ON OR BEFORE THE LATEST DUE DATE.
